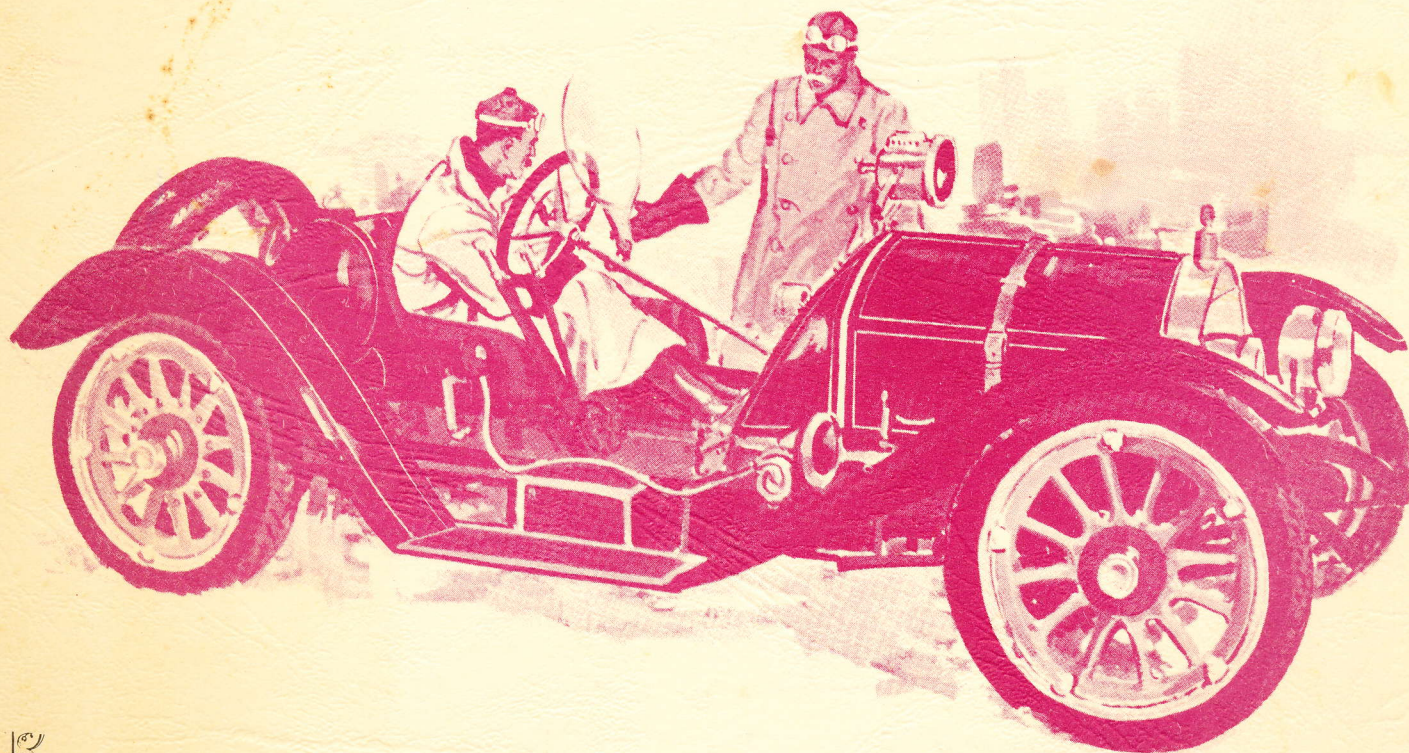

Automobile storage was discussed, but not resolved. Jack Stuart presented figures on bonded warehouse storage. It was suggested that members call the Storage Space Committee, consisting of: Dennis McCann, Bud Congdon, David Johnson, and Jack Stuart in order that a telephone listing can be made as a preliminary step to determine the actual number of cars to be stored. Jim Latham suggested some of the recently vacated automobile dealer buildings could be investigated.

Ken Barry reported that the treasury status showed some \$459 in cash and/or accounts receivable. Ken also reported that a number of members were still delinquent with their local regional dues of \$2.00. Members are cautioned that, if regional dues are not paid during this month, they will probably be dropped from the regional membership roster and mailing lists. Bill Ashby reported on correspondence from Carl Law, National Safety Chairman for AACA, concerning national safety legislation. It was reported that the current federal safety legislation would not ban antique automobiles from highways. Jerry Peoples was appointed chairman and Cecil Eddins as a committee member for the Safety Committee; Bill Fuhr has already been appointed chairman of the Safety Committee for the Tennessee Valley Chapter with Calvin Rogers as a committee member.

The Hospitality Meet, scheduled to be held in Huntsville on 26 August, was discussed relative to changing the date of this Meet since it conflicts with the dates of the National Meet, scheduled in Baton Rouge, Louisiana. Motion was made by Jerry Peoples and seconded by Eugene George that the meet date of 26 August, should be maintained. It is expected that the meet chairman will be named in May.

The Penney's Mall Show was discussed and Bill Hayle was named chairman of this show. Several members have volunteered their assistance; these include: Bill Caldwell, Don Huffine, Tom Holly, Kelly Hill, Bill Spriggs, Ken Kirby, Ken Barry, David Johnson, Jack Stuart, and Jim Latham. It was announced that an antique fashion show would be definitely included as a feature of this display.

The clubroom project was discussed and the next work session is set for Saturday, 6 May, at 10 a.m. (It is hoped that our June meeting will be held in this clubroom.)

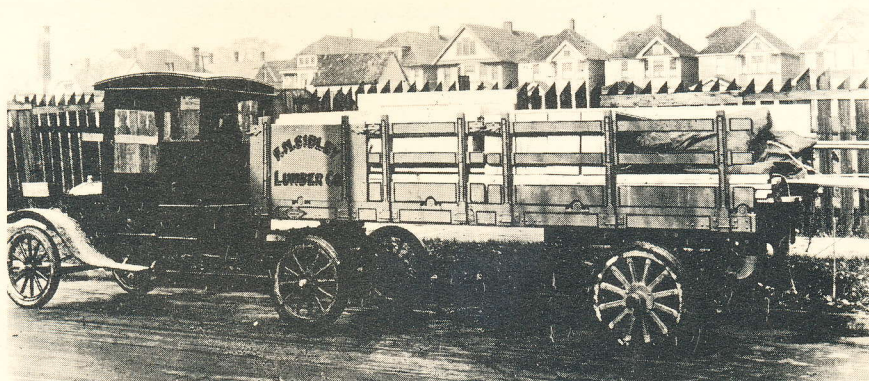

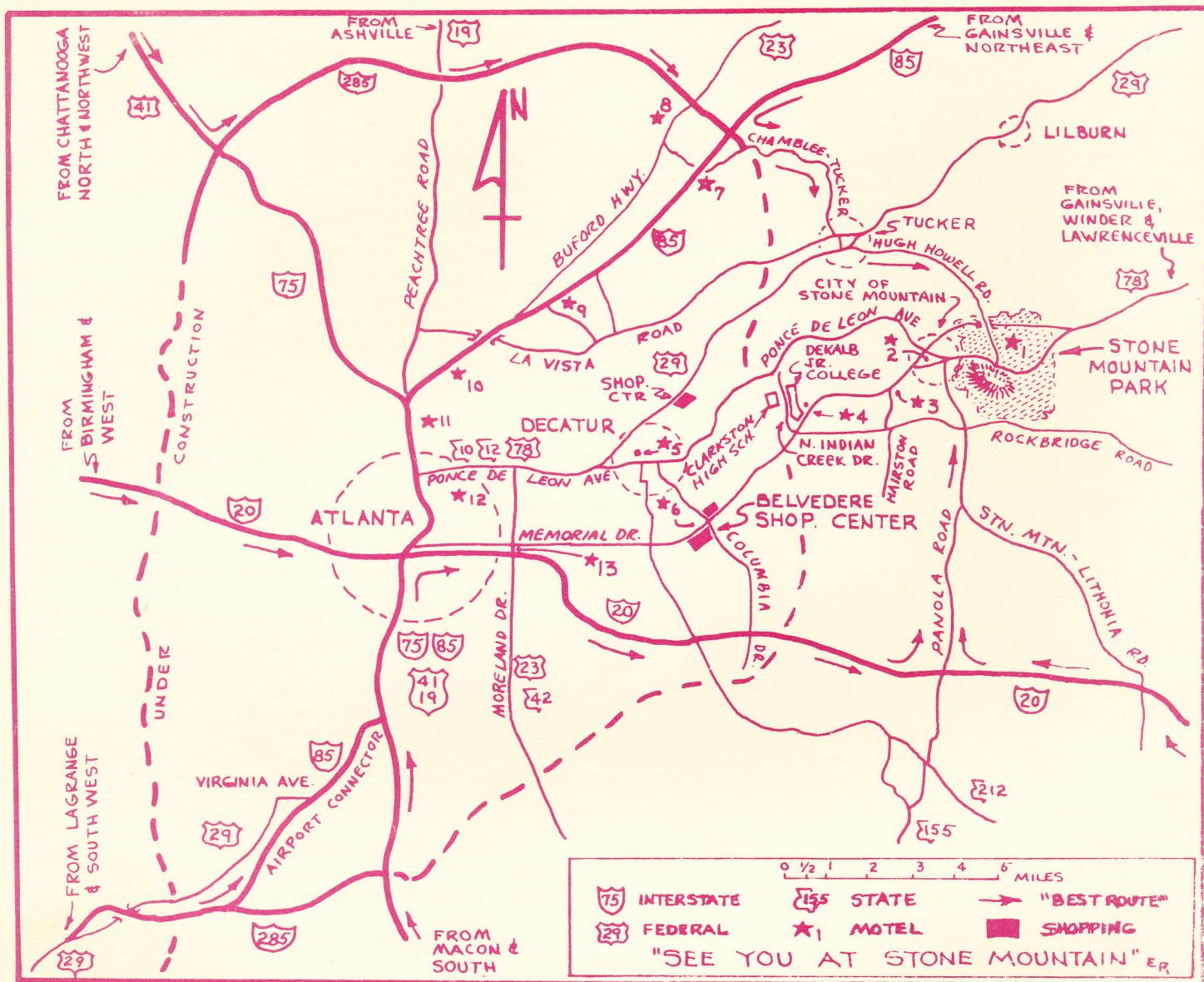

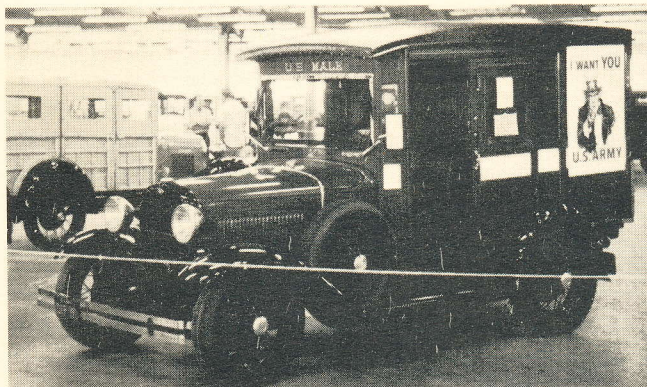

TOM TOTCKY
MODEL "A"
RESTORATION
PROJECT

Last month's issue contained a report on the status of the "Tom Totcky" Model "A" Ford restoration project sponsored by our club. Since the project was initiated over a year ago, it might be well to review its origin and intent for the benefit of our new members and to refresh the memories of our veteran membership.

Thomas J. Totcky was a member in good standing and close friend to many of this club when an unfortunate drowning accident claimed his life on Labor Day 1965. Space prevents our describing the details of the accident, but it involved Tom's unselfish and heroic attempt to save the lives of several members of another family who were all strangers to Tom.

At the time of Tom's death he had been preparing to restore a wooden, van bodied, mail truck built for a 1929 Model "A" Ford chassis. A picture of a restored truck similar to Tom's is shown above. Tom had discovered and purchased the wooden van body in his home state of Michigan, still crated in a partially assembled kit form as originally supplied to Ford by its manufacturer. A majority of the necessary components to complete the restoration had been collected by Tom before his death. The running gear is that of a standard 1929 Model "A" passenger vehicle, as are the cowl, hood, fenders, running boards, and splash aprons.

Our club felt that restoration of this truck as a club project would be a fitting tribute to Tom's memory in view of the circumstances of his untimely yet heroic death. There was no intention of establishing a precedent in the event of other member deaths.

Initial progress on the restoration was brisk with many members of the club actively participating. The restoration has been thorough thus far with complete disassembly, cleaning or sandblasting, and reconditioning of every mechanical or chassis component. At the risk of overlooking someone who has helped on the project, a few names will be mentioned below

along with their task or contribution. Bill Hayle donated the running gear and is cleaning a few parts. Ernest Cross and Olan Chiles provided many hours of labor and organization on the whole project as well as donating considerable parts. Leonard Brown donated labor and materials on the fender preparation and priming task and will provide labor for the finish painting. Those who have reconditioned components include Bill Constable, Berny Geir, Bill Varnadoe, Erny Azary, Ed Zogg, Don Huffine, Ken Barry, Dennis McCann, Dr. Becraft, Jim Beal, Porter Frady, and Jerry Peoples. Dan Shady applied body work and primer to the cowl section. Don Pryor rebuilt the drive train-rear end-rear spring assembly. Contributors of parts and cash include Houston Wright, Bill Elliot (Huntsville Auto Parts), Bill Fuhr, Dale Crites, and Chuck Mitchell. My apologies to anyone omitted.

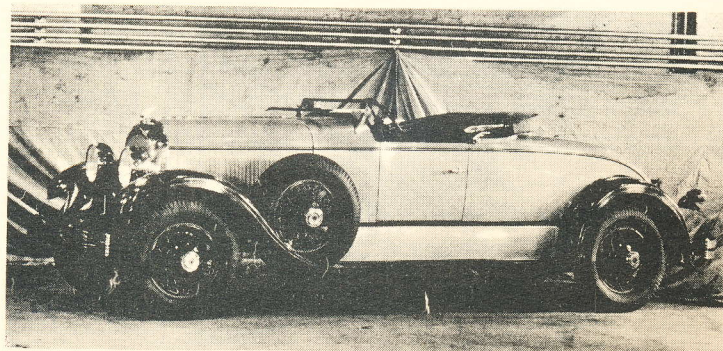
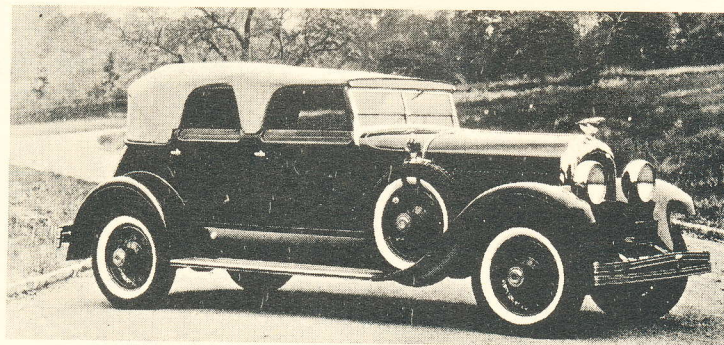
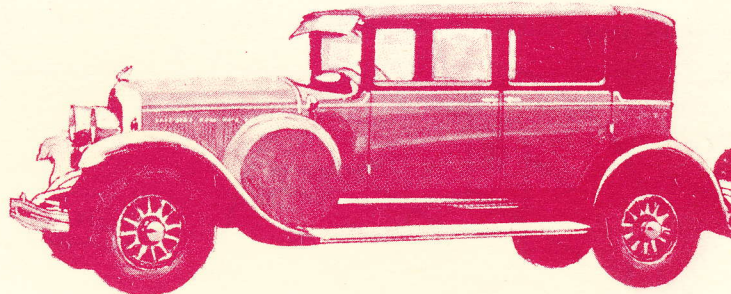
After the initial activity a slack period prevailed and only recently has progress resumed. Ken Barry and Don Pryor volunteered as co-chairmen for project revitalization to aid Ernest Cross, the project leader. As mentioned in the last issue, Don Pryor and Dan Shady are coordinating the assembly of the running gear-chassis. The engine is being partially overhauled and will probably require about \$60 for machining labor and new parts. Dan will supervise its reassembly while Don is rebuilding the transmission. The only items now lacking to complete the running gear are a battery support bracket, battery, and service brake rods. Parts which we now have but are badly worn and actually need replacing include the rear brake drums, the left and right steering arms, the pitman arm, and front spring. The radiator needs a flush job and probable minor leak repair. There are three front springs available for disassembly, culling, cleaning, and reassembly but as yet no volunteer has taken this job. Any of these items and/or labor would be greatly appreciated and your support is solicited.

Upon completion of the few remaining running gear sub-tasks, Dan and Don will assemble the complete chassis. A completion date of May 15 has been projected. At that time, the major task of body assembly and finishing will get underway in earnest. The wooden body will require some finishing work before final painting. The hood requires body work and priming; all sheet metal will then be finish painted. The body and sheet metal can then be assembled on the running gear. No estimate is available for completion of the overall project, but it is hoped that it can be accomplished by mid summer. A call will be issued for volunteers during body finishing to help in the sanding and paint rub-out phases. This should offer an excellent opportunity for valuable experience to those restoring their own cars.

Since the last fund report, \$65 has been expended for necessary running gear items as listed on the parts list circulated at that time.

Only a few members responded to the needed parts request and the remaining items had to be purchased. This leaves approximately \$130 in the fund out of which the \$60 engine rebuild bill must be paid, with paint, upholstery, chrome, etc., remaining before the project is complete.

The club as a whole realizes our commitment to finish this project and everyone should lend as much support as possible. Members are urged to give serious consideration to this project before we enter into any additional club activities which might overtax our manpower or resource capability to the point that this earlier commitment cannot be met in a timely matter.



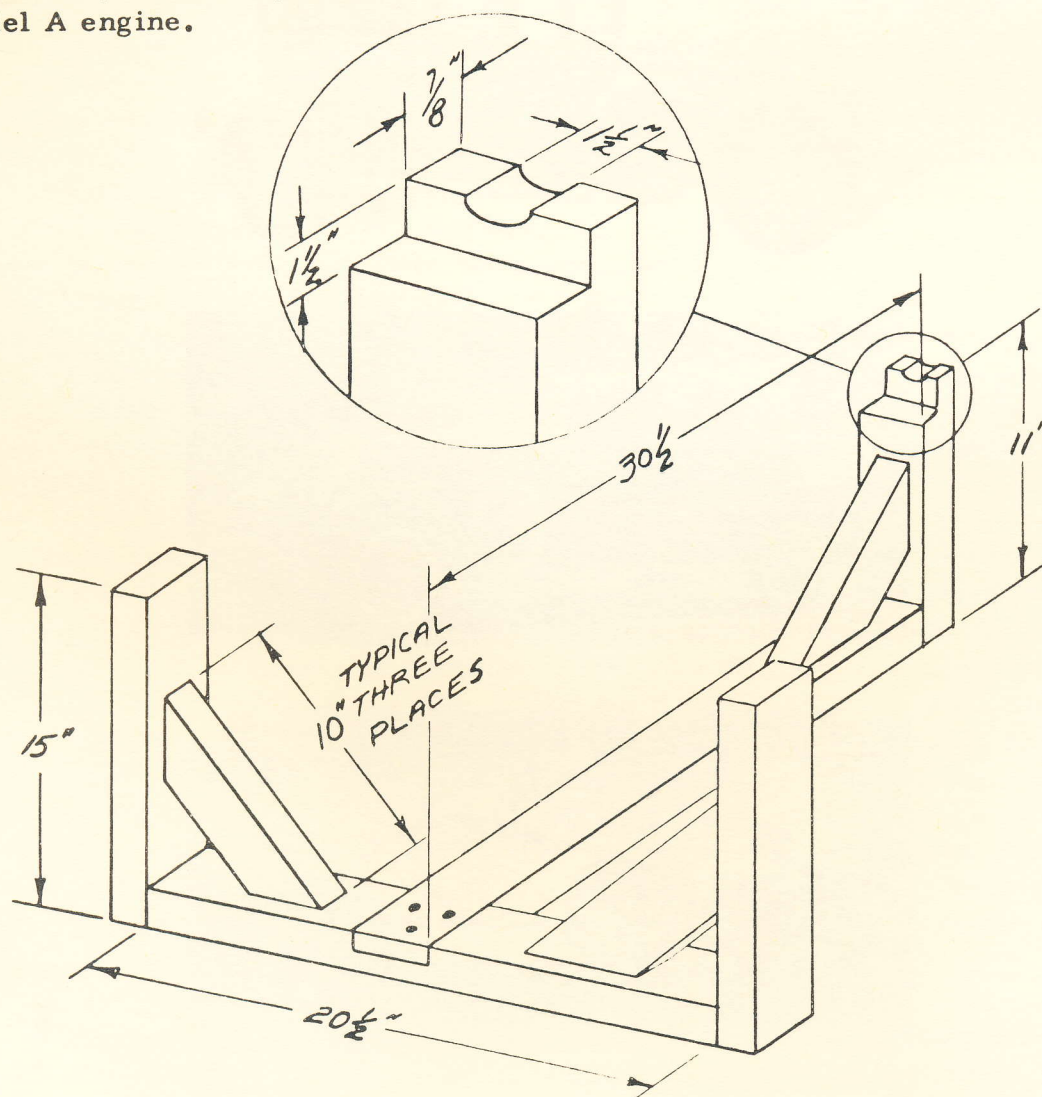
Chrysler Imperials of the late 1920's.

FORD FIX AND FACTS

The Model T engine and transmission assembly is a cumbersome piece of machinery to handle and is inconvenient to store. I have built a small engine stand modeled after the originals which makes both a convenient storage rack and an assemble bench. Since the stand loads the crankcase in the same manner as it is when installed in the car, there is not any unusual stress imposed upon the unit. All construction is of wood and parts are cut from 2 x 4's and are assembled with glue and nails. In making the front mount it is advisable to first drill a hole a little larger than 1 1/2 inches in a short length of 2 x 4 and to then saw through the hole to form the mounting surface. The block should then be sawed to the correct length as indicated in the drawing.

For those individuals who did not get a chance to view the Dunnivant's Mall Show, Dan Shady has built an excellent stand from channel iron for a Model A engine.



Helpful Hints

BLUEING
STEEL



Part "A"

Dissolve 1-3/4-lbs. of sodium hydroxide in one pint of water and let cool in refrigerator, until solution is about 50° F, use a metal pan as glass will break when heated.

Part "B"

Dissolve 3/4-lbs. of ammonium nitrate in part "A" very slowly, stirring the solution to prevent foaming. Continue to mix solution, after all the ammonium nitrate has been added. Start to heat solution over a very low flame while stirring. Continue to heat solution until it boils at 290 F then add the clean steel parts to the boiling solution. Boil parts for about 30 minutes. Remove parts from solution and wash with cold water, then oil parts for a deeper blue.

Caution must be used when trying this method as the boiling caustic solution is very dangerous.



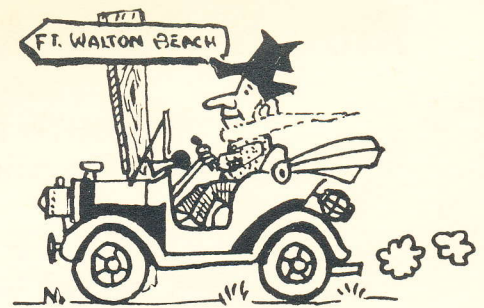

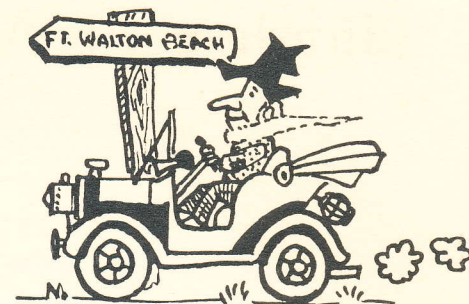

NORTH ALABAMA REGION
ANTIQUE AUTOMOBILE CLUB OF AMERICA
BY-LAWS

ARTICLE I NAME

- Section 1. This region shall be known as: "The North Alabama Region of the Antique Automobile Club of America."

ARTICLE II OBJECT

- Section 1. The purpose of this organization shall be to supplement the activities and goals of the Antique Automobile Club of America (AACA) and to provide mutual enjoyment for its members.
- Section 2. The North Alabama Region of AACA shall be a non-profit organization.

ARTICLE III MEMBERS

- Section 1. Members must be members in good standing of AACA.
- Section 2. Applicants become members after complying with the following:
- (a) Attend at least one meeting.
 - (b) Submit proof of AACA membership.
 - (c) Submit recommendations from three members in good standing.
 - (d) Submit a properly executed application form.
 - (e) Be subjected to a 2/3 approval vote of members present at the next regular meeting after items (a), (b), (c) and (d). (The vote is to be taken with the applicant absent.)
 - (f) Pay the current dues.
- Section 3. Membership is terminated by:
- (a) Allowing dues to become over 60 days in arrears. Ex-members under this clause must comply with Section 2 to become reinstated.
 - (b) Unanimous vote of the Board for conduct unbecoming a member, or other just cause, provided the member has had a full opportunity to hear and reply to the charges or reasons for such action.
- Section 4. Members whose dues are in arrears by less than 60 days, are not members in good standing and may not vote; they are returned to good standing upon dues payment.
- Section 5. An Honorary Membership for a specified time may be awarded by the members. Dues payment is not required of Honorary Members, and their AACA membership dues shall be paid by the Region for the period of their Honorary Membership.
- Section 6. The amount of annual dues shall be specified by the board. Members who have not paid dues after February 1st shall be considered in arrears. Members joining after July 1st shall pay one half the annual rate.

ARTICLE IV OFFICERS

- Section 1. The elected officers shall be:
- (a) Regional Director
 - (b) Assistant Regional Director
 - (c) Secretary
 - (d) Treasurer
 - (e) three Regional Board Members
- Section 2. Elected officers must be active members of AACA.
- Section 3. Nominations shall be open from the floor at the November meeting. Election shall be by plurality vote of members present at the November meeting. Vote shall be by secret ballot, except if only one candidate is nominated.
- Section 4. Officers assume office on the 1st of January after the election, except those elected under Section 5 who assume office at once, and serve until the following January 1st or until their successors have been duly elected and qualified.
- Section 5. Any office that becomes vacant during the year shall be filled by a special election at the next meeting following two weeks written notice.
- Section 6. A temporary Director may be appointed by the board for an official function in the absence of both the Director and Assistant Director.
- Section 7. Duties of the officers:
- (a) Regional Director - The Director shall preside at all meetings. He shall appoint all committee chairmen, except the Activities Committee. He shall call regular meetings, and specify the time and place for said meetings. He shall appoint a Nominating Committee in October.
 - (b) Assistant Regional Director - The Assistant Director shall act as Director in the absence of the Director and shall serve as chairman of the Activities Committee.
 - (c) Secretary - The Secretary shall keep minutes of all meetings, handle all official correspondence, and perform such other duties of the office as may be prescribed by the board.
 - (d) Treasurer - The Treasurer shall collect and disburse the funds of the Region as directed by the board. He shall render a financial report at the December meeting and upon direction of the Director or Board. He shall determine the validity of an applicants AACA membership and send the member his regional membership card upon compliance with Article III, Section 2.

ARTICLE V MEETINGS

- Section 1. There shall be at least six regular meetings throughout the year.
- Section 2. The Director may call special meetings with written notice to the members.

ARTICLE V (Con't)

- Section 3. At least two weeks written notice is required for the November election meeting, special election meetings, and for any meeting considering a by-law amendment.

ARTICLE VI EXECUTIVE BOARD

- Section 1. The Executive Board shall consist of the elected officers of the Region, the Regional Director of the preceeding year, and all Chapter Chairmen.
- Section 2. The Board may set policies, disburse funds, conduct any business and proceed in any manner not specifically outlined in these by-laws.

ARTICLE VII COMMITTEES

- Section 1. The following committees shall be standing committees:
(a) Correspondent to the Regional and National Publications.
(b) Activities Committee.
- Section 2. The Nominating Committee shall select a slate of at least one and preferably two nominees, who are willing to serve, for each elective office.
- Section 3. Such other Committees may be appointed by the Director as moved by the members or the board or as deemed expedient by the Director.
- Section 4. No committee chairman shall serve past January 1st, unless his appointment is renewed by the new Director.

ARTICLE VIII AACA REQUIREMENTS

- Section 1. Policies established in the Constitution of the AACA concerning use of the AACA name and AACA sponsorship shall be binding upon this region.
- Section 2. The provisions of the Constitution and by-laws of the AACA concerning Regions and Chapters, their chartering and obligations to AACA, shall be binding upon this region.

ARTICLE IX PROCEDURES

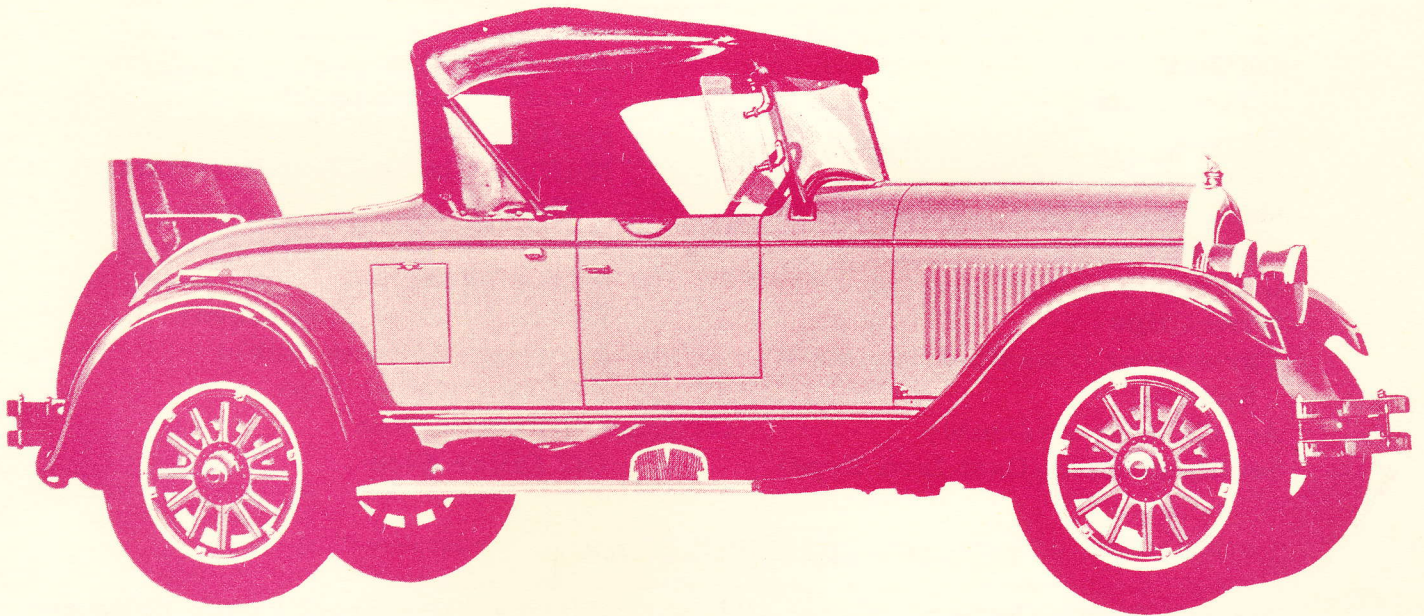
- Section 1. Robert's Rules of Order Revised shall govern procedures at all official meetings, except as herein specifically provided or excepted.
- Section 2. At any regular or special meeting members may pass motions which initiate actions, set policies, rescind board motions or actions, disburse funds or conduct other business.
- Section 3. The Board may not rescind a motion properly passed by the members. Any member action under Article IX, Section 2, has precedence over a prior board action.

ARTICLE X METHOD OF AMENDING THESE BY-LAWS

Section 1. Article VIII and Section 1 of Article X of these By-laws may not be amended.

Section 2. Proposed ammendments must be submitted to the members in writing at lease two weeks prior to the meeting at which they are to be considered.

Section 3. A quorum for passing amendments shall be 25% of the members and shall be passed with a simple majority vote of the members present.

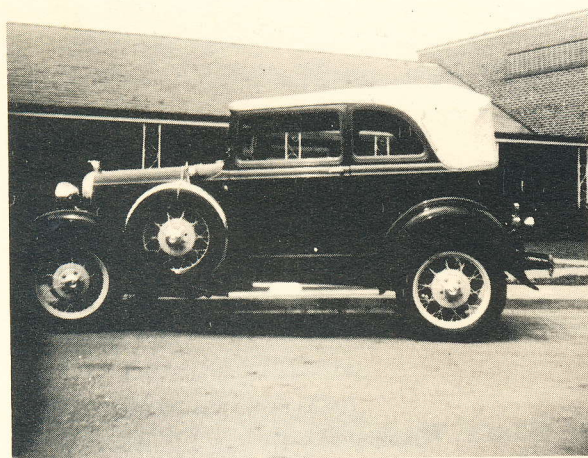

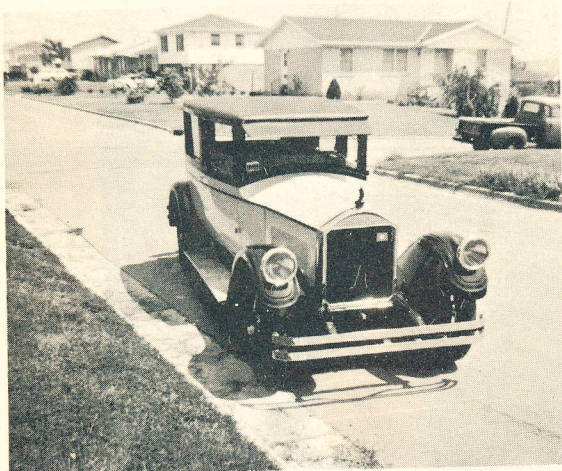

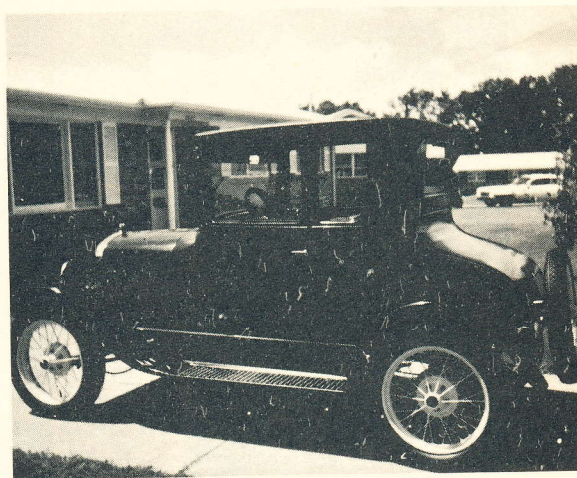

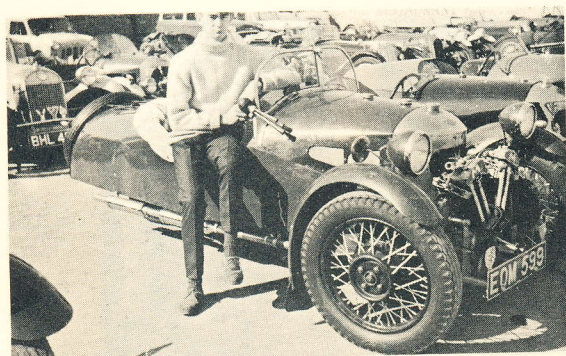

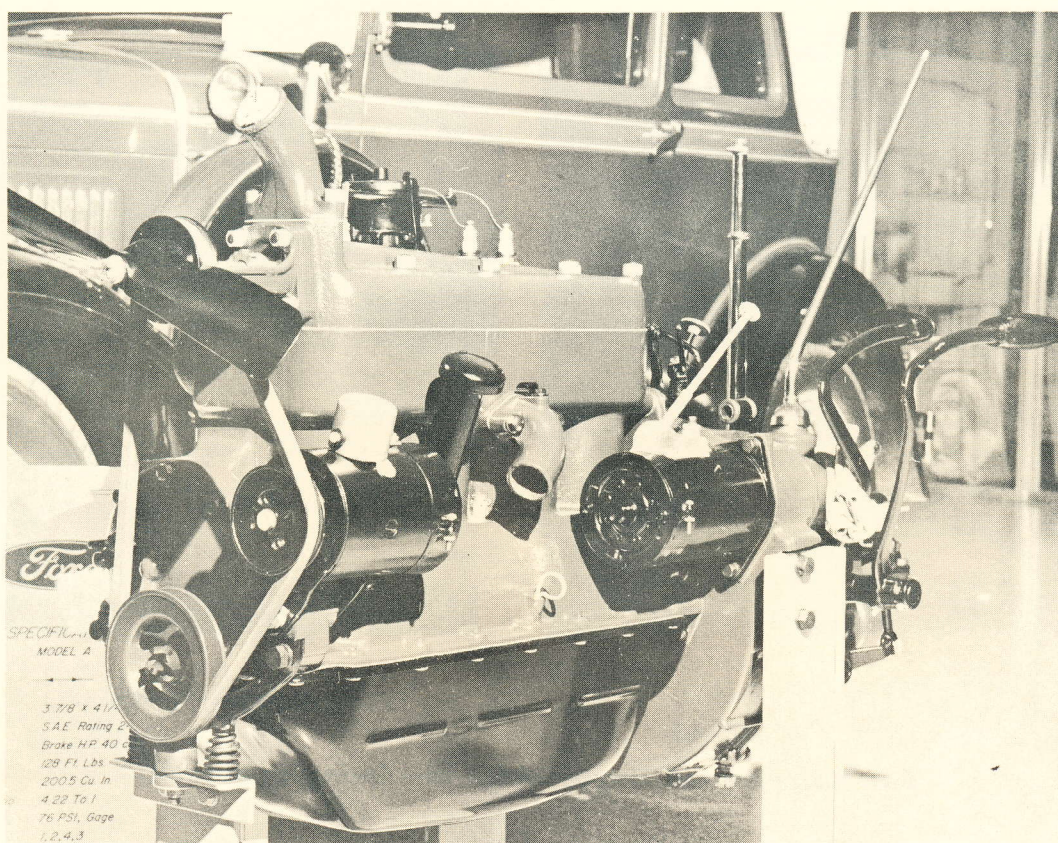

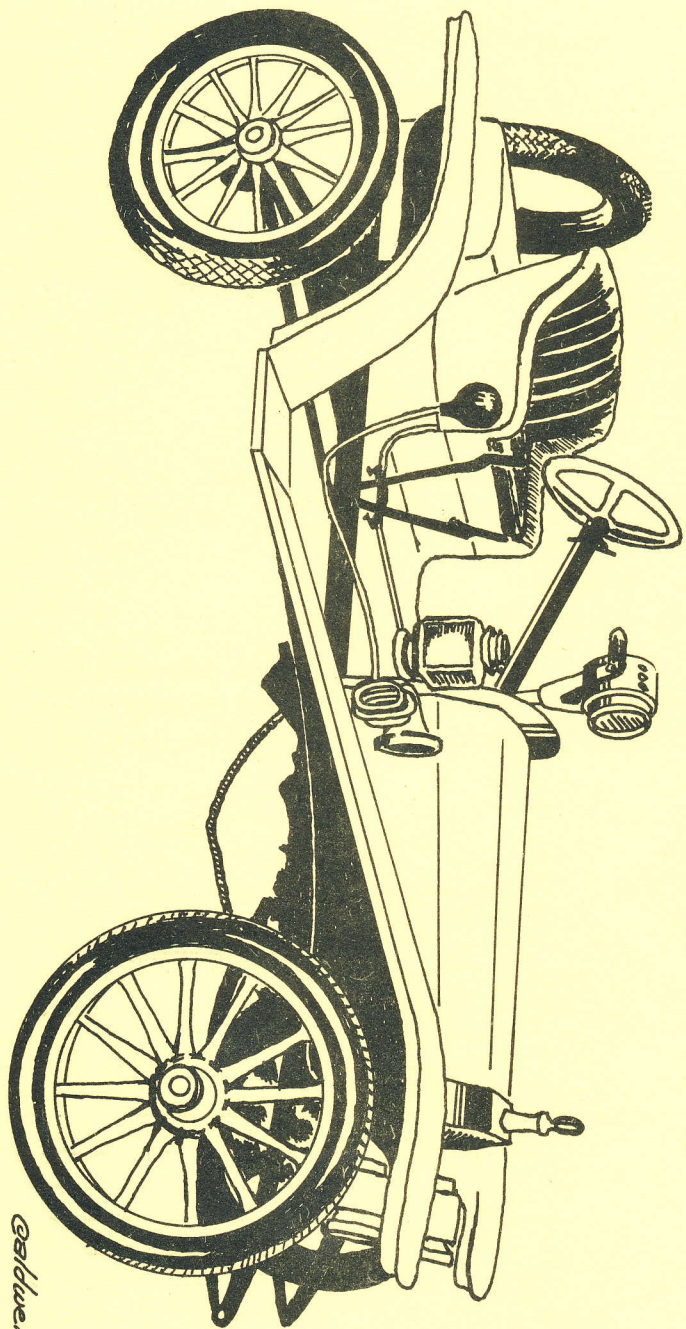
