

BERNIE AND CAROL GIER'S 1931 FORD, DELUXE COUPE

Passing the home of Bernard and Carol Gier at 3615 Purdy Drive, N W Huntsville Alabama 35810, one would never dream that such a car as pictured is in the garage under cover. The prize winning antique is a 1931 Ford Deluxe Coupe that Bernie has had since May 13, 1957 -- before a lot of us became interested in such a sport as antique cars.

The restoration that began in October 1963 was virtually completed at the National Meet in Chattanooga, Tennessee, back last October and resulted in a tie with Mr. James Hogue of Clarksville, Tennessee for first prize. The colors of this beautiful A are black fenders Chicle Drab middle and Copra Drab upper. To the writer, the Drabs are a variation of green, but to an ex-GI, oh well, they are a beautiful combination of colors. By the way, how do you suppose a Model A would look without black fenders?

The one-owner car was purchased from Mr. Willis C. Dupont, Collins Center New York with 78,000 miles showing on the odometer for the sum of \$30.00 (yes, the decimal point is correct). It had been in dry storage for about seven years and had resulted in flat tires and a frozen engine. Other individuals had tried repeatedly to buy the car during the years, but Mr. Dupont could not stand to see it fall to the fate of the 'Hot Rod'. As usual, Bernie promised Mr. Dupont that when the restoration was completed he would return and show the car to him. This seems to be a standard bargaining practice for buying antiques.

After the sale was completed and the towbar was hooked up for the 25 mile trip to Eden New York. Mr. Dupont couldn't quite understand how the vehicle could be towed without a driver. After satisfied that it would follow the tow vehicle, the owner for 26 years sat behind the steering wheel for what turned out to be the last time. Mr. Dupont passed away a short time later without seeing the car again After talking with Mr. Gier. I'm sure that Mr. Dupont must have felt that he did the right thing by selling to Bernie.

After arrival at Eden. New York, the old Ford received another engine and was made roadable again. It was at this time in the Ford's life that the owner was required to 'do time' -- U. S. Army, October 1957 - October 1959. The newly acquired possession was again in storage and was only run when Mr. Gier was home on leave. Bernie was stationed at Redstone Arsenal, Huntsville, Alabama, for about six months. He has quite a story about how he got away from here.

After the U. S. Army tour, the Ford was stored two years until towed to Fayetteville. North Carolina, and again stored two years until restoration really began in October 1963. Let Bernie tell you about backing a tow setup down a snow-covered mountain.

Bernie also took time out along here for things such as an illness marriage, etc.

As the restoration was getting well underway, the move to Hunts-ville Alabama, came about. Again the towbar was hooked up. If anyone has questions about towing, see Mr. Gier, he is experienced. During the restoration the biggest problem was splash aprons. One was obtained from Texas, the other from North Carolina. Some other parts were obtained from as far away as Canada and California. The car was completely disassembled, inspected, and repaired during the restoration. The major painting was done in North Carolina before coming to Huntsville.

While unattended one afternoon, the front fenders were used as a slide for some children and resulted in a thorough rubbing off of that beautiful paint job. Mr. Leonard Brown and Mr. Gier repaired this damage beautifully.

When the upholstery was about 70 percent done, panic hit. It seemed there would not be enough material for completion, but there was. The Bedford cord material took six months to obtain. The upholstery was made and installed in one day by two people who worked 42 hours. Figure that day out.

As one has a tendency to do, Mr. Gier got behind and was required to work 14 hours a day for about 3 days in order to make the National Meet in Chattanooga, Tennessee, in October 1968. Mr. Gier was working just ahead of the judges at that meet. It paid off because he tied for first place in his class. He also shares the Tocky Award with Mr. Herb Fulmer for 1968. The Tocky Award was presented at the Christman party in December 1968.

Bernie and Carol enjoy their new 38-year old car very much. They drive it weekly, weather permitting, etc.

Congratulations on a fine job that Mr. Dupont and Mr. Ford would be proud of.


DISPLAYS

Each display should be accompanied by a comprehensive poster so that the people observing can be informed or what they are seeing at our mall shows. The posters need not be fancy, but they should be legible. They should be readable from at least eight feet away. past shows I have observed people walk by a car (without any more information presented than a name and year on a small sheet of paper) and never give it a second look. On the other hand, the same people would read every word on a paster by an adjacent car and would even strike up a conversation with other bystanders about the car. Simple handwriting on relatively stiff card stock with a felt-tip pen would be sufficient.

The type of information that people are interested in is as follows:

- Where it came from (barn, geographical location, etc.) 1.
- 2.
- Did it run (good, almost, are you funning me?)?
 Any oddity in getting it home (outlaw fuel system, friends saw you, but didn't (wouldn't) know you)?
- Any odd thing found inside (like two 1929 dimes and a snake skin, year undetermined)?
- Weight, length, etc. ' Engine specifications
- Unusual systems (chassic lube, hand crank, etc.). 7.
- Extensive use of materials, or techniques, such as aluminum casting, etc.
- Time spent in restoration.
- 10. Original cost.
- Estimated value (If desired. Be careful not to exagerate). 11.
- 12. Prizes won.
- 13. Color names.
- 14. Number produced, and remaining.
- Does it run? (It's amazing how many people ask this 15. question.)

This is not saying we should present a spill, a sales pitch, etc., but I do think that most people are interested to a degree and would like to know more about our cars.
